

Dear parents, guardians,

Subject: GSV-Payment of fees- school year 2020-2021

There are certain rules linked to membership of The “Groningse Schoolvereniging” concerning contributions of fees. Every year the income-related index increase will be followed as laid down in the CAO-PO 2020. The board of Association has set the increase at 2.5 % for the fees contribution for 2020-2021.

The scales for the combined taxable income are adapted yearly to the CPI, Consumers Price Index. For 2020 the scales will be raised with 1,5%. The Participation Council has agreed with this proposal.

The International Department of the Groningse Schoolvereniging has its own scale of fees. The combined taxable income of your household determines in which category you fall regarding the school parental contribution. For practical reasons everyone is placed into the highest category and will receive invoices at this level, unless information is provided to prove otherwise. Any such details must be given via penningmeester@g-s-v.nl , before **September 15th 2020**.

From 1st September 2020, new parents will only be able to pay in 1 or in ten monthly instalments. The policy of the GSV is to encourage as many parents as possible to make payments via a digital fee collecting system, Wis-collect.

Payment Terms

New members (member after 1 September 2019) are only able to make payments in 10 monthly installments. This will take place in the period from October 2020 to July 2021.

For all other members, those who pay monthly will have the amount debited between October 2020 and July 2021, and parents who pay once a year will have it debited in October.

The calculation of the fees for families who are coming and/or leaving during the school year will be charged on a monthly basis.

The financial administration will be carried out by the school’s administration as well as by an external administration office of the Foundation GSV. The external administration office (OBM), will use the system of Wis-collect. We will inform you more about this new debit program through the parental

portal Mijnschool. The verification of the charging of the fee will be carried out by the board of the Association of the Groningse Schoolvereniging.
